Topic: “Countering the Threat of a Cyber-Attack – Handling Crisis Communication in the Light of the new Data Protection Regulations”

Cyber-security is currently one of the most discussed topics within German and Japanese companies. The damage caused by cyber-crime already amounts up to one trillion dollars. Politicians have responded to this threat: As of May 25, 2018, companies within the EU will be obliged by law (GDPR) to report an attack to the relevant authorities. This measure increases the pressure on companies to adjust according structures and procedures. The DJW event will outline the new regulations, simulate a cyber-attack and offer insights how to prepare for and deal with it. Our speakers will present an interactive simulation of a major reputational crisis striking a large Japanese corporation operating in Germany. Participants will experience how to deal with such a situation via a digital, fully interactive, real-time crisis simulation tool and learn how to respond to traditional and social media, customers and other stakeholders.
